WHEREAS, the Ohio Auditor of State's office performs vital financial audits of the accounts, financial reports, records and files of all public entities to ensure that public funds are spent appropriately and lawfully; and

WHEREAS, the Portage Lakes Career Center is currently undergoing its FY23 financial audit by the Ohio Auditor of State; and

WHEREAS, in the course of the audit, a concern was raised that a Board-approved incentive program

violates CFR 668.14(22)(i) which broadly prohibits an institution accepting Title IV funds from providing incentive pay based in any part, directly or indirectly, upon success in securing enrollments to any person who is engaged in any student recruitment or admission activity; and

WHEREAS, the Board is committed to exceptional fiscal responsibility and transparency, and maintains a profound desire to comply with all local, State and Federal obligations; and

WHEREAS, while the Board was unaware that its incentive strategy was problematic, it nevertheless appreciates the diligence and integrity of the Financial Audit Group undertaking the audit and the opportunity to rectify its policies, procedures and practices to demonstrate its unwavering commitment to financial integrity and to ensure immediate compliance.

NOW THEREFORE BE IT RESOLVED that effective immediately, the Board hereby revokes the Enrollment Specialist Performance Incentive contained in the 2022-2023 Adult Education Employee Handbook and the 2023-2024 Adult Education Employee Handbook.

BE IT FURTHER RESOLVED that effective immediately, the Board amends the base salary scale of the Enrollment Specialist as follows:
